

PUPPY SALES CONTRACT

High Desert Aussies, owners of the said puppy (described below) hereafter referred to as "Seller" do enter into an agreement with, _____ hereafter referred to as "Buyer", for the purpose to transferring ownership of the said puppy.

The said puppy is a purebred Australian Shepherd, sired by _____ and out of _____. The puppy is a _____. The said puppy's date of birth is _____ and registers with AKC and/or ASCA. Registration papers will be transferred at the time of sale. The seller will transfer ownership of the said puppy for \$ _____, with limited registration, unless otherwise agreed up on. \$ _____ was paid to hold puppy and the balance of \$ _____ will be due at 6 weeks of age or at the time of pickup .

Guarantees:

High Desert Aussies guarantees the puppy to be free of major diseases (Parvo, Distemper, Corona, Rabies) for a period of 24 hours from the date of sale stated on the Pet Records. We also recommend that you take your new puppy to your vet within the first 72 hours of receiving.

High Desert Aussies also guarantees this puppy to be free of genetic defects until the puppy is 2 years old. If the puppy is found to have a genetic defect it will be replaced with another puppy of the same sex from the first compatible litter. No money will be refunded. Buyer is responsible for the shipping cost of the replacement puppy. We are not responsible for any vet bills.

If your puppy displays any indication of poor health within the first 24 hours, we must be contacted and the puppy must be brought back or taken to our veterinarian for any necessary treatment. Puppies that go out of state must go to a licensed veterinarian and signed documentation must come to us immediately. Failure to do so will cause this guarantee to become null and void.

Also, this guarantee shall become null and void if the puppy is given any vaccinations or medications other than what is specified on the medical records received with the puppy.

**The health guarantee dose not cover any parasite, internal or external,
as this is a treatable condition.**

Contract (Spay/Neuter)

By signing this contract I understand & agree to the following:

I agree to be a responsible pet owner & spay/neuter at an appropriate age BEFORE bad behavior develops, typically 6-15 months, as recommended by my vet. I understand that pounds, shelters, and rescues are full of unwanted, unhealthy, genetically untested, mixed breed animals due to irresponsible pet ownership and failure to spay/neuter. If left intact my dog could;

1. Be shot at while visiting a neighbor's dog to breed
2. Contract a sexually transmitted disease from a neighborhood animal causing harm to his/her health as well as my family
3. WILL contribute to the overpopulation of unwanted animals simply by breeding my neighbor's intact dog because THEY ARE ANIMALS ... THEY WILL FIND A WAY.

I will NEVER register this dog as any other breed than the breed listed on his/her AKC registration paperwork. This requirement is put in place to protect and preserve the quality & pureness of the breed.

I will NOT receive a refund in the event I simply change my mind regarding this purchase, find a cheaper, lesser quality puppy elsewhere, suddenly develop allergies, or my landlord disagrees with my purchase. Adding a new puppy to my household can be a 15 year commitment therefore I have invested a considerable amount of thought into my decision BEFORE making a commitment to purchase. Life changing events can happen and should I be unable to keep my puppy at any time during his/her life I WILL contact the breeder/seller for arrangements to return, or gain assistance in re-homing, my puppy and will never forfeit ownership to a pound, rescue, or shelter.

This puppy WILL require medical attention at some point during his/her lifetime & I, the buyer, am prepared to pay all vet expenses from this point forward. I am making this purchase because I believe this puppy is in good health at time of sale & was produced by a responsible reputable breeder.

This puppy has recently been de-wormed & the shedding of parasites may still be occurring & is normal after treatment. Healthy vaccinated puppies are still susceptible to contagious disease, parasites, & protozoa though every effort has been made to prevent this unfortunate occurrence.

Third party sale makes this contract null & void as does evidence of abuse, neglect, accident, or lack of adequate quality food, water, & shelter. Breeder/seller will not be responsible for injury or accident to puppy, or cost for repair, once he/she leaves breeder care. In addition, no guarantee will be provided for eye color and ear set.
